#### 6. Principal Updates – Raven Jones

Raven was very thankful to the outgoing and incoming board and explained that coming into her first full year as the principal she expects to become increasingly engaged with the PTSA.

She reflected on the challenges of establishing a new leadership team after 14 years with MHS led by Dr. Reid, and that this work is ongoing. A key program will be the establishment of a school Steering Committee, made up of staff, teachers, students, and parents. The goal is to review the needs of the school vs. the current state and provide a strategic roadmap that will be followed and continuously updated. Many schools use such a model and find it quite helpful. She encourages PTSA members to be on the lookout and to volunteer some of their time for this important program.
